Katherine has been a producer, director, manager, fund developer, arts adviser and jury member, and chair of several boards. Well known for his critical approach and public engagement both as writer and as national librarian. Author of nine books (fiction, essays, theory). His prose have been selected in several anthologies of contemporary Serbian literature. His books have been translated into German and Macedonian. His stories and essays have been translated into English, German, French, Slovenian. Member of the Serbian PEN Club.

Her Phd thesis, "The embodied representation. An ethnography of the body between colonial stereotypes and contemporary art", examined the works of the Afro-American artists Lorna Simpson and Kara Walker, focusing on colonial representation, the concept of embodiment and emotions as field of knowledge's production. She teaches Photography – social communication at the Fine Arts School of Brera (Milan, Italy), Visual anthropology and Sociology of communication at the European Institute of Design (IED) in Rome. She is editor-in-chief of the on-line journal roots§routes – research on visual culture. She is currently research fellow at "L'Orientale" (Naples, Italy) as a member of the EU Project "Mela – European Museums in the Age of Migrations" (founded as FP7-SSH-2010/2012), where she is working on the relation between museums, contemporary anthropology and contemporary art. Prof Rebecca Kay and Prof Alison Phipps (University of Glasgow and Glasgow Refugee Asylum and Migration Network)

Rebecca Kay is Professor of Russian Gender Studies (Central and East European Studies). Prof. Kay is interested studying gendered experiences of socio-economic, cultural and political transformation in contemporary Russia since the early 1990s. In addition to this, she is committed to furthering dialogue between researchers across geographical (East/West) and disciplinary boundaries and between academics, policy-maker and practitioners. The ESRC-funded seminar series 'Transnational Issues, Local Concerns: Insights from Russia. Central and Eastern Europe and the UK' (2003-04) was an important experience to explore and understand the multiple processes of transformation taking place in the postsocialist region and beyond, but also, specifically, to cross some of these geographical, disciplinary and professional boundaries. Prof. Kay is also interested in the geopolitics of welfare and globalisation of care, and the complex, and often interdependent, relationship between material welfare and emotional care in producing social security at local, national and global scales. Alison Phipps is Professor of Languages and Intercultural Studies (Creativity Culture and Faith). Her research interests focus on languages and intercultural studies, with a particular critical concern for the different ways in which people learn to live and communicate together, by stepping outside comfortable or familiar contexts. Her work is interdisciplinary and draws on the resources of social and cultural anthropology, theatre and cultural studies, theology, law, modern languages and education. Her Ph.D. research and ethnographic training focused on open air community theatre in Germany. She has continued ethnographic work among tourists, modern language students, adult learners of tourist languages, in conflict transformation and among sanctuary and asylum seekers, refugees and befrienders. At present Prof. Phipps is developing research on languages and intercultural advocacy with asylum seekers and refugees; and developing her work and workshops on education for peace and nonviolence with a growing focus on constructions of faith and on the contribution of theological perspectives. Together with Rebecca Kay, she co-convenes the Glasgow Refugee, Asylum and Migration Network.

Dr Ellen McAdam, Head of Museums and Collections for Glasgow Life

After reading archaeology at Edinburgh and Oxford she undertook post-doctoral research in museums in the Near East, UK, USA and Europe, and was Research Fellow of the British School of Archaeology in Iraq. Returning to Britain, she worked for a number of heritage organisations before joining Glasgow Museums in 2001 as Collections Services Manager, responsible for the physical and intellectual integrity of the city's internationally significant collection. She has contributed to the delivery of a number of HLF-funded projects including the Kelvingrove New Century, Riverside Museum and Glasgow Museums Phase 2 projects. She is currently leading on the development of the joint Kelvin Hall project with the Hunterian Museum and National Library of Scotland, and of the project to refurbish the Burrell Collection. She has lectured and published widely on Near Eastern and British archaeology and is an Honorary Lecturer in Archaeology at the University of Glasgow. Recent publications include Excavations at Barrow Hills, Radley, Volume 2: the Romano-British cemetery and Anglo-Saxon settlement (with RA Chambers, 2007) and Navigations, voyages, traffics and discoveries: early European travellers to Mesopotamia, in Your Praise is Sweet. A memorial volume presented to Jeremy Allen Black by colleagues, students, and friends (2010, eds H Baker, E Robson, G Zólyomi).
